The **Chief AI Officer (CAIO)** owns an organization's AI strategy, value, and accountability, balancing innovation against governance, risk, and regulation. It's an executive role, and it's appearing fast across enterprises and government.

WHAT THE CAIO OWNS

- Enterprise AI strategy and the AI investment portfolio
- The AI governance operating model (policies, councils, risk tiers)
- Alignment with the **NIST AI RMF**, **ISO 42001**, and the [EU AI Act](#)
- Executive and board reporting on AI value *and* AI risk

THE BACKGROUND THAT GETS YOU THERE

CAIOs typically combine **senior technology or data leadership** with **governance and risk fluency**. You need to speak both languages: shipping AI value and defending it to regulators, auditors, and the board.

CREDENTIALS & SIGNALS

At this level, a track record matters more than certs, but executive-level governance credentials (board-readiness programs, IAPP AIGP, ISACA's AI audit credentials) and published thought leadership strengthen candidacy. Full details and salary data are in the [GRC Certifications Guide](#).

THE PATH

1. **Lead AI initiatives** with measurable business outcomes.
2. **Own governance** — stand up an AI policy, risk framework, and council.
3. **Build executive presence** — board reporting, public speaking, writing.
4. **Network at the top** — CISO, CDO, CRO, and general counsel are your peers.
5. **Target the role** — **browse live Chief AI Officer roles on GRC Careers**; adjacent titles: Head of AI, VP AI Governance, Chief AI & Data Officer.

[Is the Chief AI Officer a technical or governance role?](#)

Both. The CAIO sets AI strategy and delivers value, but is equally accountable for AI governance, risk, and regulatory compliance, so executives blend technology leadership with GRC fluency.

Most come from senior technology, data, or analytics leadership, combined with strong governance and risk experience and board-level communication skills.
